Amendment to the Investment Policy Statement of the Santa Fe Conservation Trust

Purpose: To amend the Investment Policy Statement dated April 7, 2015 by:

- 1. Revising the strategic asset class categories to more clearing identify the key areas of portfolio utility and adjust the strategic allocation to reflect updated modeling. Asset class names will change as follows:
 - a. Income will now be named Income Generation
 - b. Capital Growth will now be named Core Growth
- 2. Updating allocations to underlying Core Growth assets classes (reduce International Equity and increase Domestic Lg Cap and Sm/Mid Cap Equity
- 3. Updating downside risk modeling from the 99th percentile to the 95th percentile.
